Dear Secretary McMahon,

We write to express our strong opposition to the Department of Education's (Department) plan to eliminate the Office of English Language Acquisition (OELA).¹ We are very concerned that such a decision will adversely affect the approximately 5.3 million English learners (ELs) who rely on the programs in U.S. public schools supported by federal funds. Congress created OELA² to ensure that English learners and immigrant students develop English proficiency. It stretches credulity that the Department could determine whether such proficiency was occurring without having an office specifically designed to assess the learning of English. The Department's decision will undoubtedly disrupt the administration of programs designed to support English learners.

OELA is dedicated to implementing certain programs authorized under title III (Title III) of the *Elementary and Secondary Education Act of 1965* (ESEA), including grants for English Language Acquisition and Language Enhancement. These grants support language instruction programs, professional development for educators, and other critical resources to support multilingual students.³ Eliminating OELA as a standalone office would weaken the Department's capacity to support ELs. In the absence of a designated office committed to the unique needs of ELs, these actions could significantly reduce the Department's ability to provide needed support to states and districts. OELA has historically served as a major federal resource for guidance and research for states and districts. Further, it is responsible for administering and monitoring nearly \$900 million in Title III-Part A funds. With the elimination of OELA, states and districts may face reductions in essential programs and services, including language instruction and teacher preparation programs.

States rely heavily on OELA for targeted guidance and technical assistance to support ELs and without a dedicated office, states may face major challenges sustaining these services. States also depend on the funding from OELA as the primary entity to provide specialized support for ELs. Reassigning these functions to different offices could cause disruptions and increased gaps and inefficiencies in service delivery of support for ELs, due to the lack of staff experience and expertise with OELA functions. Additionally, eliminating OELA would limit federal oversight and accountability under Title III, which would reduce the Department's ability to ensure that states are meeting their legal obligations to support ELs. These actions would further undermine Congress' intent to provide equitable learning opportunities for ELs. This closure, combined with the Department's reduction-in-force (RIF) actions, which decimated staff at OELA and the Office for Civil Rights, threatens to eliminate all federal support and enforcement of civil rights protections for ELs.

We strongly urge the Department to immediately stop its efforts to eliminate OELA. We demand that you keep Congress informed on any next steps and any actions that would further diminish the support for English Learners and their Congressionally authorized pursuit of English proficiency.
